NOTICE OF PERMIT RENEWAL

To Whom It May Concern:

Pursuant to the Utah Coal Mining and Reclamation Act (Utah Code Annotated 1953, Section 40-10-1 et seq), and the "Regulations Pertaining to Surface Effects of Underground Coal Mining Activities" (Final Rules of the Utah Board of Oil, Gas and Mining), the Utah Division of Oil, Gas and Mining has issued a renewed permanent program mining permit to Valley Camp of Utah, Inc. for its permit application No. ACT/007/001.
