1. PERMIT -

The permittee has submitted several amendments to the Division. The inspector at the PFO has reviewed and given comments and recommendations to the SLO permit supervisor. The amendments are currently being reviewed by a Hydrologist at the SLO. The final review date has been set by the SLO.

The permittee has submitted an amendment to pump slurry pond fines into abandoned parts of the coal mine. This project may be delayed till Spring due to winter weather if SLO review and approval is not rapid.

4a. DIVERSIONS -

The diversions in several areas were cleaned out. The ditches by the coal stockpile were functioning as designed.

4b. SEDIMENT PONDS -

The sediment ponds were inspected for third quarter of 1997 with no hazardous conditions being reported. The mine site pond is expected to be cleaned out 1997 pending Division approval.

4c. EFFLUENT LIMITATIONS -

The mine sediment pond did not discharge for third quarter of 1997.

7. SPOIL PILE -

Spoil pile was inspected for third quarter with no hazardous conditions being reported.


21. INSURANCE AND BONDING -
