Dear Mr. Miller:

As you are aware, the mitigation plan which was requested as part of the remedial action to abate the two-forementioned notices of violation uncovered a deficiency within the currently approved mining and reclamation plan for the White Oak Mine, i.e. no interim revegetation plan existed. To correct this, an amendment to the existing plan proposing an interim seed mix was submitted and approved by the Division on May 11, 2000 (ACT/007/001-AM00C).

Since the Division approved this interim seed mix, it is now acceptable for Lodestar to proceed with the mitigation plan for these two notices of violation as submitted to the Division on April 13, 2000.
