Dear Mr. Miller:

As allowed by R645-301-524.300, the owner of a structure within one-half mile of any part of the permit area may request a preblasting survey. On October 18, 2001, the Division received a request, made by Questar Pipeline Company, for a preblast survey of their pipeline facilities near the White Oak Mine Complex (see attached letter).

In accordance with the above regulations, Lodestar Energy Inc. must promptly conduct a preblasting survey of the natural gas pipelines owned and operated by Questar and prepare a written report of the survey. The written report will be signed by the person who conducted the survey and copies of the report must be promptly provided to the Division and to Questar. If Questar disagrees with the contents and/or recommendations contained in the report they may submit to both Lodestar and the Division a detailed description of the specific areas of disagreement. All surveys will need to be conducted and any disagreement will need to be resolved prior to conducting blasting at the White Oak Complex.


