SECOND NOTIFICATION

RE: Responses to the Issues Concerning the Milton A. Oman, Ltd. Estate Stated in the May 24, 2002 Letter to your Attorney Frank G. Patrick and follow-up to Certified Letter August 9, 2002 and Returned August 27, 2002

Dear Mr. and Mrs. Weiss and Mr. Cain:

Lodestar Energy, Inc. is writing this letter to bring to your attention the issues that were raised in the May 24, 2002 letter still need to be addressed.

A formal letter from you or your attorney to Lodestar Energy formally identifying the estate's contact person or persons by name, address and telephone number.

The post-mining land use in Section 30 of Township 13 South Range 6 East (the mine site) needs to be identified in a letter from you to Lodestar Energy.

The road across the reclaimed area at the mine site can not be left at the end of mining if the typographic error is not corrected changing the statement that the "Lessor" would install the road instead of the "Lessee". A letter agreeing to this change and a formal amendment to the lease with signatures and recording of the document will be required.

The last issue is the haul road from Eccles Canyon to the Oman property. The land owner must provide a letter stating the need and use for the road to remain and what type of road will be required for your use. A responsibility and maintenance agreement stating that the land owner will accept the responsibility and maintain the road after the bond is released on the mining permit. An agreement will also need to be attained from the Madsen/Hammond land owners agreeing to this road being left on their property. Since the road also crosses their property on the way to the Oman property at the mine site.

DOGM has requested that these issues be resolved by December, 2002.
