1. Permits, Change, Transfer, Renewal, Sale

I was unable to inspect the mine site due to snow cover. The loadout could be partially inspected. No hazardous conditions could be seen at the loadout. The gate was unlocked at the loadout and appears that the railroad was using the gate to gain access to the track.

8. Noncoal Waste

There is some non-coal waste material that can be seen through the snow at the loadout. There are transformers on the ground at the loadout.

15. Cessation of Operations

All reclamation activities by the Division has stopped for the winter. Reclamation will begin in the Spring of 2005.
