Sediment pond at the loadout is snow covered and appears stable.

Eight to twelve inches of snow covers the loadout with snow drifting in places to 24 inches. The mine site was inaccessible.

**16.a Roads: Construction, Maintenance, Surfacing**

The loadout access road is plowed by the railroad for crew access. The road to the mine site is not plowed and approximately one foot of snow covers the road.
