13. Revegetation

Mr. Robert Aycock (landowner representative) and I made presentations to the Skylline Cooperative Weed Management Board (SCWMA) in early February. The Board approved a field day on July 23, 2013 to spray herbicide on musk thistle and other weeds at the White Oak mine site and loadout and within an area from Clearcreek west to the USFS boundary and north to Eccles Creek. The support of the SCWMA means that there will be many operators spraying at one time. Mr. Aycock will contact landowners, oil & gas companies for their support.
