Snow has mostly melted from the loadout and from the mine access pad. Snow is still piled in deep drifts along the edge of the access pad.



4.a Hydrologic Balance: Diversions

Water is flowing through the 36 inch culvert in Eccles Creek. At the loadout, water is flowing through the culvert C-14-24 to Mud Creek.

4.d Hydrologic Balance: Water Monitoring

There was no noticeable flow at the confluence of Whiskey Creek and Eccles Creek.

Snow has mostly melted from the loadout site. Snow covers the reclaimed access road to the mine site.

The gate to the loadout was open. A railroad maintenance truck was parked alongside the tracks at the loadout.

There was no evidence of any entry to the reclaimed mine site on either the logging road up Whiskey Creek or the reclaimed mine access road.
