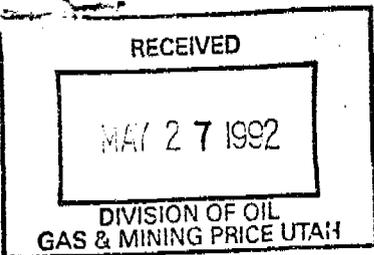

Dear Mr. Demczak:

As requested of Richard Allison last month, enclosed please find seven (7) new pages (numbered 9 through 13b) containing the latest ownership and control information for the Castle Gate mine operation located near Helper, Utah.

Please note that pages 9 through 13 are formatted so that the information contained thereon generally corresponds to the old pages of the same number now in the permit. However, I have also included two additional pages numbered 13a and 13b. These pages were not contained in the original permit section but are necessary to document the complete listing of the names and address of directors for AMAX Coal Company and AMAX Land Company.

AMAX Coal Company is undergoing reorganization and decentralization. For Castle Gate, this means that ownership information is in a state of flux. For example, Castle Gate Coal Company, Blackhawk Coal Company and Meadowlark Utah, Inc. have all become AMAX Land Company. However, because of the magnitude of the documentation, the legal records including deeds, leases, and other ownership information have yet to be completed. Further, because of the reorganization, the directors are also subject to change.

Please be advised, therefore, that the information furnished today is correct to the best of my knowledge. However, as we discussed in our phone conversation earlier this month, it may not be totally accurate when compared with court house records. Further, the aforementioned corporate reorganization makes this information subject to daily change. Stating with accuracy the ownership and control information for Castle Gate at this time is similar to being blindfolded and trying to pin a tail on a moving donkey.

While this is true, you had indicated in our phone conversation that even with the above caveats, the submitted information would be acceptable to your office. Assuming that this is still the case, would you review the submitted pages and provide me with your any other comments you may have. 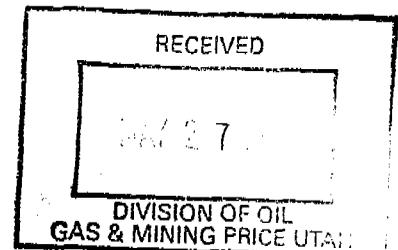

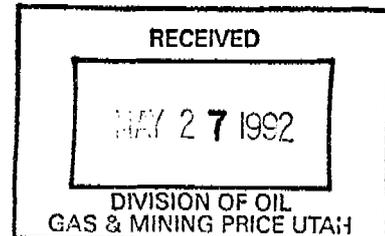

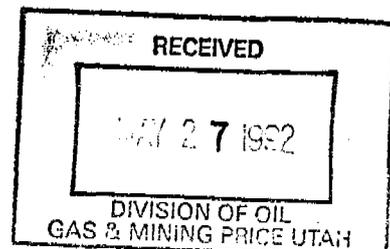
