4. Hydrologic Balance

a. Diversions

Because of the snow, I was unable to measure the depth of HCRD-10. The configuration of this channel is really part of a much larger problem, the way the entire Goose Island area was graded. I now believe the best way to handle the grading problems at Goose Island is to write a Division Order. It is a complex problem that is much better handled through the permitting process rather than enforcement.
