There are two amendments pending, Subsidence monitoring, AM01A, and reclamation of the #1 adit, AM01B. Subsidence monitoring is scheduled for approval the week of June 4th and the adit proposal is currently under review.

During the past two weeks Vicky and Johnny have been collecting water samples from some of the sampling locations.

13. REVEGETATION

This year's vegetation growth at the Sowbelly site is developing well. There was no evidence of Whitetop on the north facing slope of the upper right fork of the reclaimed area. There was also no evidence of the noxious plant the previous year. According to Vicky, there was a small amount of the plant in this area several years ago.
