The sign containing the required information was posted at the access point to the #1 Adit.

4A. HYDROLOGIC BALANCE: DIVERSIONS

The sediment control structures were in good repair and were functioning properly at the Adit. There was minimal flow from the spring. The flow extends about half way across the reclaimed area.

13. REVEGETATION

The Adit: Vegetation has emerged through the straw mulch in the roughened areas and is showing 6"-10" of new growth.
