1. Permits, Change, Transfer, Renewal, Sale

Signs were adequately posted at the entrances to the Hardscrabble and Sowbelly sites.

13. Revegetation

The vegetation at both sites is doing well. General observations indicate that the grass species are becoming the dominate vegetative community at the Hardscrabble site. The next site visit will include a visual comparison of the existing species with the approved seed mix.
