1. Permits, Change, Transfer, Renewal, Sale

The permit was renewed December 24, 1999. The application for permit renewal was received on August 20, 2004 and the review is due to be completed on December 24, 2004.

2. Signs and Markers

Signs containing the required information were posted at access points to the reclaimed areas.

4.c Hydrologic Balance: Other Sediment Control Measures

Surface roughening, vegetation, diversions, and water bars are the sediment controls for the reclaimed areas. There was no evidence of off site sediment loading from these areas.

4.d Hydrologic Balance: Water Monitoring

Water monitoring for the third quarter of 2004 was completed on September 14, 2004. All locations were dry, sites B11, 12, 28, and 45 as the undersigned accompanied Mr. Pappas during the quarterly sampling.

4.e Hydrologic Balance: Effluent Limitations

13. Revegetation

The intermittent rains during July and August have been beneficial to the vegetation at the reclaimed sites.
