**1. Permits, Change, Transfer, Renewal, Sale**

The permittee has submitted an application for phase one bond release for the substations in Hardscrabble and Sowbelly canyons. December 1 is the scheduled review date by the Division. The permit was renewed December 24, 1999. The application for permit renewal was received on August 20, 2004 and the review is due to be completed on December 24, 2004. Public notice for the permit renewal had been completed. Mr. Ware was preparing the information to be included in the application.

**2. Signs and Markers**

Signs containing the required information were posted at the access to the reclaimed area.

**12. Backfilling And Grading**

There were three as-built maps for the substation reclamation in Sowbelly canyon in the DOGM files. During the inspection, Mr. Ware and I took the maps to the site for ground truthing. Exhibit 3.2-13 was the accurate as-built map. This was also confirmed by Lane Jensen, the PE from Earthfax Engineering Inc., who prepared the exhibit.
