1. Permits, Change, Transfer, Renewal, Sale

The permittee submitted an application for phase one bond release for the substations in Hardscrabble and Sowbelly canyons. On December 16, DOGM sent the deficiency letter and TA. Response is due by 3/1/05. The permit was renewed December 24, 2004.

2. Signs and Markers

Signs containing the required information were posted at access points to the reclaimed area at the Adit. Did not look for signs at Sowbelly or Hardscrabble.

4.a Hydrologic Balance: Diversions

Adit: Channel was not flowing, but was damp in certain areas and snow covered in others.

4.c Hydrologic Balance: Other Sediment Control Measures

Surface roughening, vegetation, diversions, and water bars are the sediment controls for the reclaimed areas. There was 6" of snow at this location and unknown depth at the Hardscrabble and Sowbelly locations.

9. Protection of Fish, Wildlife and Related Environmental Issues

Adit: deer tracks were observed.
