The Hardscrabble Canyon inspection will begin at 9:00 a.m. at Swift Stop and Shop 156 N Main (intersection of Highway 6 and Main Street) in Helper.

If you need directions to the Sowbelly Canyon, please let me know. Due to the proximity of the two sites, most people will be interested in attending both inspections.

Access to the area is on dirt and gravel roads. A vehicle with good ground clearance is recommended. The inspection will include moderate hiking on rough steep terrain.
