1. Permits, Change, Transfer, Renewal, Sale

The Mine and Reclamation permit will expire on December 24, 2009.

2. Signs and Markers

The identification signs were located at the mine gates. Information was correct.

3. Topsoil

All topsoil has been used to reclaim the mine sites.

4.a Hydrologic Balance: Diversions

The diversions were open and would function during a rain storm event.

4.c Hydrologic Balance: Other Sediment Control Measures

Roughening and vegetation is used as sediment control measures.

4.d Hydrologic Balance: Water Monitoring

The permittee has entered third quarter water information into the EDS.

4.e Hydrologic Balance: Effluent Limitations

No DMR's have been taken since March 30, 2003.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was reclaimed. No inspections were taken or required.

8. Noncoal Waste

The mine site was clear of non-coal waste materials.

12. Backfilling And Grading

All areas are backfilled and graded.

13. Revegetation

Areas are well vegetated.

18. Support Facilities, Utility Installations

No facilities at reclamation sites.

21. Bonding and Insurance

The insurance policy is by Steadfast Insurance Company. The policy number is BOG5086545. This policy will expire on 7/30/07. The bonding amount is \$490,100 as of 3/20/06.
