The reclaimed site is pocked for sediment control. The amount of vegetation on the site also reduces sediment movement. There are no signs of erosion to the sites.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

All refuse piles are reclaimed and no inspections are required.

**8. Noncoal Waste**

The site was clear of non-coal waste materials.

**10. Slides and Other Damage**

No slides or damage was noticed during the inspection.

**12. Backfilling And Grading**

The sites are completely reclaimed. All backfilled material was used.

**13. Revegetation**

This site in my judgment most areas are highly vegetated. The constance amount of rainfall has caused the vegetation to grow high.

**18. Support Facilities, Utility Installations**

There are no facilities at Castle Gate.
