2. Signs and Markers

Identification signs are at the gates to the property.

3. Topsoil

All topsoil was used in reclamation.

4.a Hydrologic Balance: Diversions

Diversions are opened and many of the diversions are grasslined.or having shubs within the diversion.

4.c Hydrologic Balance: Other Sediment Control Measures

The reclaimed site is pocked for sediment control. No signs of sediment leaving the site.

7. Coal Mine Waste, Refuse Piles, Impoundments

The site has been reclaimed and no inspections are required.

8. Noncoal Waste

The site was clear of non-coal waste materials.

10. Slides and Other Damage

No slides or damage was noticed during the inspection.

12. Backfilling And Grading

The sites are completely reclaimed. All backfilled material was used.

13. Revegetation

Vegetation is abundant at No.#3 mine throughout the property.

16.a Roads: Construction, Maintenance, Surfacing

The road is graveled running through the property at Hardscrabble Canyon. There is no road at #5 Mine.

16.b Roads: Drainage Controls

The drainage is functioning as designed.

18. Support Facilities, Utility Installations

No facilities are at Castle Gate.
