1. Permits, Change, Transfer, Renewal, Sale

The permittee has not submitted any amendments to the Division.

2. Signs and Markers

The identification sign is located in front of adit #1 reclamation. The information on the sign meets the minimum requirements of the R645 Coal Rules.

3. Topsoil

All topsoil was used in reclamation.

4.a Hydrologic Balance: Diversions

The diversion at addit #1 was open and functional. No water was flowing within the diversion. There was no water flow within the diversion.

4.d Hydrologic Balance: Water Monitoring

There was no water flow for the fourth quarter of 2012.

8. Noncoal Waste

The site was clear of non-coal waste materials.

10. Slides and Other Damage

I did not see any slides or other damages during the inspection.

12. Backfilling And Grading

The site in my opinion meets AOC standards. The site appears to be stable and no signs of slides or any other damages.

13. Revegetation

Some of the vergetation is snow covered.
