1. Permits, Change, Transfer, Renewal, Sale

The permittee has not submitted any amendments to the Division. No amendments are likely to be submitted to the Division until Phase III bond release is requested by the permittee. The permit expires on December 23, 2014.

2. Signs and Markers

The identification sign is located in front of adit #1 reclamation. The information on the sign meets the minimum requirements of the R645 Coal Rules.

3. Topsoil

All topsoil was used in reclamation. I did not see any topsoil erosion during the inspection. The topsoil appeared to be stable.

4.a Hydrologic Balance: Diversions

All diversions were open and were functioning as designed. Some of the diversions have vegetative bottoms.

4.c Hydrologic Balance: Other Sediment Control Measures

Adit #1 and the two sub-station areas are completely pocked to prevent topsoil erosion.

4.d Hydrologic Balance: Water Monitoring

There was no sampling because the streams were dry.

8. Noncoal Waste

The sites were clear of non-coal waste materials.

10. Slides and Other Damage

No slides or other damages were noticed during the inspection.

12. Backfilling And Grading

The three sites are completely backfilled and graded. All site were stable.

13. Revegetation

Vegetation has done well this past summer at the two sub-stations and adit #1.
