## **2. Signs and Markers**

The identification sign is located in front of adit #1 reclamation. The information on the sign meets the minimum requirements of the R645 Coal Rules.

### **4.a Hydrologic Balance: Diversions**

All diversions were open and were functioning as designed. Some of the diversions have vegetative bottoms. The diversions appear to be stable.

### **4.c Hydrologic Balance: Other Sediment Control Measures**

The three reclaim sites are completely pocked. This is to prevent sediment from leaving the site and to help with the growth of the vegetation. I did not see any signs of soil erosion or sediment leaving the reclaim sites.

All three site were clear of non-coal waste materials.
