**1. Permits, Change, Transfer, Renewal, Sale**

In 2014 the permittee will be submitting an application for Phase III bond release of two sub-station and Adit #1 sometime in early spring. The total area is less than 3 acres. These areas are well vegetated. There should be no problems receiving Phase III bond release.

**2. Signs and Markers**

The identification sign is located in front of adit #1 reclamation. The information on the sign meets the minimum requirements of the R645 Coal Rules.

**3. Topsoil**

All topsoil was used in reclamation. I did not see any topsoil erosion during the inspection. The topsoil appeared to be stable. The ground was slightly snow covered.

**4.a Hydrologic Balance: Diversions**

The diversion was open at adit #1. A slight amount of water was flowing into the diversions. The diversion meets the design requirements. It is stable and no signs of erosion.

**4.c Hydrologic Balance: Other Sediment Control Measures**

The reclamation site is reclaimed and the ground is pocked for sediment control.

**8. Noncoal Waste**

The three reclaim sites were free of non-coal waste materials.

**10. Slides and Other Damage**

No slides or other damage was noticed during the inspection.

**12. Backfilling And Grading**

The three sites were reclaimed to AOC.

**13. Revegetation**

The vegetation should meet the vegetated requirements.
