1. PERMIT -

Skyline Mine will be submitting updated transportation maps to the Division by January 1995. Since there is construction going on, maps will need to be changed.

The mine will also update the Alternate Sediment Control information in the Mining and Reclamations Plan.

4a. DIVERSIONS -

The diversions were graded. Snow was present in several ditches. Water was flowing to the ponds with no hinderance from the snow. Water was not bypassing the ditches.

4c. OTHER SEDIMENT CONTROL MEASURES -

The mine had 19 inches of snow. The silt fences are functional and withstood the snow fall. The ASCA structures were treating the runoff as designed.
