



To Whom It May Concern:

Enclosed are Application for Permit Processing forms C1 and C2 for the permit amendment and one copy of redline and strike out for page 43(a), seven clean copies of page 43(a), seven copies of Plate 2.3.6-1, and seven clean copies of page 4-102. This amendment is being requested to allow us to install 9-inch Parshall flumes in Swen's and Little Swen's Creeks. These flumes will aid CFC in obtaining baseline and operational flow information. The flumes will be in place for the life-of-mine. The flumes will be held in place using sand bags and native materials to limit environmental damage.

The second request in the amendment, page 4-102, is to clarify approved revisions submitted 26 March 1998, and 6 August 1998.
