1. Permits, Change, Transfer, Renewal, Sale

The permittee has submitted an amendment to revise the reclamation of the South Fork Portals. This amendment has been approved by the Division. The permittee has started on the reclamation of the portals. The portals have been backfilled and are cover half way with refuse material. The refuse material is compacted in two foot intervals by a track hoe.

3. Topsoil

Topsoil at the South Fork turn around has been removed and stored in a topsoil pile. The topsoil pile is protected by silt fences.

4.a Hydrologic Balance: Diversions

The permittee was in the process of adding additional silt fences to protect the creek. No impact to the creek has occurred. The silt fences are a safety precaution.

4.d Hydrologic Balance: Water Monitoring

The permittee requested an extension to submit second quarter water monitoring into the Electronic Water Data System. This request was approved by the Division.

7. Coal Mine Waste, Refuse Piles, Impoundments

The permittee is using refuse material as backfilling material to reclaim the highwall. This material has been tested for acid and toxic form.

12. Backfilling And Grading

The permittee is in the process of backfilling the highwall at the South Fork Portals. The permittee is compacting the backfilling material in two foot lifts.

13. Revegetation

The permittee will be submitting a map showing different areas of seed mix.
