Fourth quarter 2006 water monitoring is in the EDI website, but has not been uploaded. Water monitoring is current.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable with no visible hazards. No material has been shipped from the refuse pile to Headwaters. Plans have changed and no immediate plans exist to pursue the test burn with Headwaters.
