2. Signs and Markers

The Mine ID signs are at the point of public access to the permit area and contain the required information. All other signs and markers are in accordance with the coal rules.

7. Coal Mine Waste, Refuse Piles, Impoundments

Mining at the main refuse pile located in the canyon above Scofield is still taking place.

No update was available as per the request to MSHA by the operator to abandon the two other refuse piles at the main facilities and load out. A discussion took place that indicated that if the piles are not abandoned that they need to follow the required inspection frequency and criteria required by the Utah Coal Rules.

18. Support Facilities, Utility Installations

Plans are being drawn up for the installations of an additional fan at the main facilities. This information will be submitted to the Division in the near future in a permit change application.
