2. Signs and Markers

The Mine ID signs are at the point of public access to the permit area and contain the required information. All other signs and markers are in accordance with the coal rules.

4.a Hydrologic Balance: Diversions

The diversions are snow covered. Need to monitor the diversion leading from the storage sheds to the main access at the parking lot entrance. The diversion should be monitored as the snow melts to assure that no obstructions to the diversion occur.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

As noted in the complete inspection on 02/12/2009 the fourth quarter 2008 pond inspections were done December 31, 2008, no problems were noted. The reports for ponds 001, 002 and 003 did not contain the estimated sediment level. The reports need to be revised to show this information. The reports have been revised, but still need a P.E. certification at which time they will be submitted to the Division.
