2. Signs and Markers

The Mine ID signs are at the point of public access to the permit area and contain the required information. All other signs and markers are in accordance with the coal rules.

4.a Hydrologic Balance: Diversions

The diversions are snow covered. Need to monitor the diversion leading from the storage sheds to the main access at the parking lot entrance. The diversion should be monitored as the snow melts to assure that no obstructions to the diversion occur.

4.b Hydrologic Balance: Sediment Ponds and Impoundments
