1. Permits, Change, Transfer, Renewal, Sale

2. Signs and Markers

The Mine ID signs are at the point of public access to the permit area and contain the required information. All other signs and markers are in accordance with the coal rules.

16.a Roads: Construction, Maintenance, Surfacing

An amendment is being prepared for submission to the Division to pave the run around road at the coal loading facility.

18. Support Facilities, Utility Installations

The new fuel off loading facility is now constructed. The pad is sunken with a sloped entrance and egress. The entire fuel off loading area is covered. The upgrade was made to comply with the new SPCC requirements for fuel off loading.

Rock dust distribution upgrades are scheduled pending Division final approval.
