

2. Signs and Markers

The mine identification signs are located at points of public access into the permit area. Signs contain the required information.

4.a Hydrologic Balance: Diversions

Large rock identified on previous inspection in the concrete lined diversion by the truck load out is still present. Rock needs to be removed to allow diversion to function as designed.

7. Coal Mine Waste, Refuse Piles, Impoundments

Refuse pile appeared stable. No visible hazards noted.
