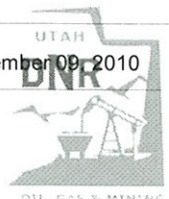

## **2. Signs and Markers**

The signs (Topsoil, Stream buffer zone and Mine ID) for the Winter Quarters construction site have been received, but still need to be installed.

Mine identification signs were observed at points of public access to the varied permit locations. These signs contained the required information.
