## **2. Signs and Markers**

The mine identification signs were observed at points of public access into the permit area at the main facility, load out facility and the winter quarters facility. All of the referenced signs contained the required information in a format acceptable to the Division.

## **18. Support Facilities, Utility Installations**

Construction of the Winter Quarters Portal has begun. The Area has been meshed and shotcreted. Steel I-Beams have been set. Initially on two foot centers in order to catch and support the top. The portal depth is in approximately six feet. Drilling was taking place during the inspection. Blasting will occur in the near future. The original public notice was issued until the end of September. Surface Blasting may extend beyond that time. Gregg Galecki has sent an additional public notice to the Sun Advocate that will lengthen the time frame till October 21, 2011.
