## **2. Signs and Markers**

The mine identification sign at the main facilities is in place and contains the required information.

Observed a stream buffer zone sign that was bent in half. The sign needs to be straightened so that it is visible. The sign location is at the beginning of the conveyor system which extends down canyon.

## **5. Explosives**

With the new portal construction at Winter Quarters powder and cap magazines will be placed in the disturbed area until the portals/tunnels are completed (approximately 6 to 18 months). The permittee has complied an amendment for submission to the Division which will show the location of the powder and cap magazine locations on the surface facilities map.

Blasting has not yet occurred at the Winter Quarters site.
