2. Signs and Markers

Observed the mine identification signs located at the main facility, load out, and refuse pile. All signs are placed where they are visible and are located at the access point into the permit area. The signs contained the required information.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment pond surfaces at the main facility and load out are frozen and snow covered. The refuse sediment pond is only snow covered, no ice or water below the snow.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable. No visible hazards were observed. Placement of spoil material from the winter quarters portal development was actively being placed on the refuse pile surface during the inspection.
