2. Signs and Markers

The mine identification signs are in place at the various points of access from the public into the permit area. The signs contains the required information.

4.a Hydrologic Balance: Diversions

Pipe leading into the sediment pond from the belt structure at the load out has a broken joint. The operator is aware of this problem and has parts on order to fix the pipe.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Rail load out sediment pond was discharging during the inspection.
