4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment level in the mine load out sediment pond has reached a level that requires the pond to be cleaned. Cleaning is scheduled to begin once the water has been removed from the pond and material starts to dry out.

5. Explosives

A blast plan has been submitted to the Division for the Winter Quarters Portals. The plan is under review and requires a signature by a certified surface blaster in the State of Utah on the plan prior to final approval.
