2. Signs and Markers

Mine Identification signs located at the main facility and Load-out facility are at points of public access into the mine permit Area. Both signs contained the required information.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Main sediment pond and load-out facilities pond are iced over and snow covered.

Explosive storage containers are separated for cap and powder storage. Both magazines are grounded and have signs. The signs are placed properly.
