Dear Mr. Ariotti:

On June 15, 2012 the Utah Division of Oil Gas and Mining has determined that the Canyon Fuel Co., LLC permit application for the addition of 770.52 acres to federal lease UTU-67939 is administratively complete. In compliance with the Utah Coal Mining Rules R645-300-121.300, R645-300-121.310, R645-300-121.320, and the Utah Coal Mining Act (UCA Section 40-10-1 et seq.), notice is hereby given to all local, state and federal agencies having a jurisdiction or an interest in the area of the operations that this application is available for review.

Skyline Mine intends to add 770.52 sub-surface lease acres in federal lease UTU-67939. The additional lease area is located in Carbon County, T.12 S., R.6 E., Sections 25, 26 and 34, beneath Granger Ridge, west of the town of Scofield, as shown on the attached map.

The legal description of the additional lease area is as follows:


