## **2. Signs and Markers**

The mine identification sign was observed during the partial inspection. The sign contained the name, address, phone number and mining permit number associated with the Skyline Mine. The sign was found to be in compliance with the Utah Coal Rules.

### **4.a Hydrologic Balance: Diversions**

The snow berm in front of the road diversion that was observed on the prior inspection has been removed. All diversions through out the site are covered with snow.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The main sediment pond is ice covered except at the end where it is currently receiving inflow. The truck load out pond is complete frozen.

## **5. Explosives**

The explosive magazines in the explosive storage area are properly signed and grounded.

## **8. Noncoal Waste**

Mine site is free of noncoal waste items outside of the approved containment.

### **16.a Roads: Construction, Maintenance, Surfacing**

Mine roads used for access to the various locations within the disturbed area have been graded and/or plowed to remove the snow and allow access.
