2. Signs and Markers

The mine identification signs located at the main facility and the load-out facility were observed during the partial inspection. Both signs were found to be in compliance containing the name, address, phone number, and mining permit number.

4.a Hydrologic Balance: Diversions

All the diversions at the mine site are covered by snow.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The surface of the main sediment pond has melted. The surface of the load-out sediment pond remains snow covered.

5. Explosives

The powder and cap magazines are properly signed and grounded.
