2. Signs and Markers

The mine identification signs are located at all points of entrance into the various locations of the mining permit area from a public access point. The signs are all uniform and contain all of the required information set forth in the Utah R645 Coal Rules.

4.a Hydrologic Balance: Diversions

The diversions are open and functional as designed

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The main sediment pond and the Load out sediment pond both contained water during the inspection.

5. Explosives

The powder and cap magazines are located in the same general area, but are spaced apart for a distinct separation. Both magazines are properly signed and grounded.
