2. Signs and Markers

The mine identification signs were observed at the main facility, rail load out and waste rock site. All signs were in compliance.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The main sediment pond and the waste rock sediment pond have been cleaned. The rail load out pond is scheduled to be cleaned.

5. Explosives

The cap and explosive magazines are properly signed and grounded.

7. Coal Mine Waste, Refuse Piles, Impoundments

Re-mining of the refuse pile is currently occurring. Pile appeared stable. No visible hazards were observed.
