2. Signs and Markers

The mine identification signs were observed at the main facility, truck load out and the refuse pile. All observed signs were uniform and complied with the Utah R645 Coal rules by providing the name, phone number address and mining permit number.

5. Explosives

The powder and cap magazines were inspected and found to be properly signed and grounded .

7. Coal Mine Waste, Refuse Piles, Impoundments

The re-mining of the refuse pile was observed during the inspection A substantial amount of material has been removed and processed. The pile maintains a positive drainage to prevent water impoundment. During the inspection the refuse pile appeared stable. No visible hazards were observed.

8. Noncoal Waste

Noncoal waste items were confined to the approved storage areas.
