2. Signs and Markers

The Identification signs were inspected. The signs meet the minimum requirement of the R645 Coal Rules.

3. Topsoil

Topsoil piles were inspected. They were stable with no signs of wind or water erosion. The topsoil piles do have vegetative cover. The permittee may acquire additional topsoil from the White Oak Project that the Division is working on.

4.a Hydrologic Balance: Diversions

In the recent past, the permittee had difficulty maintaining some of the diversions in snow covered conditions. A violation was written and vacated because the permittee did not purposely block the diversion. This is typically a degree of negligence in the assessment of civil penalties. I inspected the diversions and found one diversion which gravel/road base was pushed into a diversion and the outlet of the culvert was 1/2 filled with sediment. No snow was near or in these two areas. Working with the permittee as directed in the Fact of Violation Conference, no violation was written. The permittee has committed to cleanout the culvert outlet and the diversion.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds were inspected at the mine, rail loadout and the waste rock site. All three ponds did contain water. The mine sediment pond was discharging. No hazardous conditions were noticed. The embankments appeared to be stable.

8. Noncoal Waste

The disturbed area was clear of non-coal waste materials.

10. Slides and Other Damage

No slides or other damage were noticed during the inspection.

16.a Roads: Construction, Maintenance, Surfacing

The permittee had added road base to a road linking the upper pad to the lower pad at the Rail loadout.
