1. Permits, Change, Transfer, Renewal, Sale

The permittee has several amendments with the Division for review. These are NOG Bleeder Shaft (Sept 18), Swens Canyon Ventilation Facility (Sept 30), Reduce Macroinvertebrate (Oct 12) and Waste Rock Site Culvert (Oct 14).

2. Signs and Markers

The identification sign contained the same information as noted in Chapter 1 in the Mining and Reclamation Plan. The Identification sign meets the requirements in the R645 Coal Rules.

3. Topsoil

The topsoil piles were inspected with no signs of wind or water erosion. These piles had vegetative cover with grasses and small shrubs.

4.a Hydrologic Balance: Diversions

Diversions and culverts were open and would function as design during a storm event.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment ponds were inspected with no hazardous conditions noticed during the inspection. The Embankments appear to be stable. Most ponds did contain water.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile has been re-contoured as design. No hazardous conditions were noticed during the inspection.

8. Noncoal Waste

The site was free of trash and other non-coal waste materials.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

16.b Roads: Drainage Controls

I inspected the road drainage and the diversions and culverts were open.
