1. Permits, Change, Transfer, Renewal, Sale

There is one permitting action currently with the Division. It is the Skyline Flat Canyon Lease. The review date is schedule to be finish by January 29, 2016.

2. Signs and Markers

The identification sign contained the same information as noted in Chapter 1 in the Mining and Reclamation Plan. The Identification sign meets the requirements in the R645 Coal Rules.

3. Topsoil

The topsoil piles were snow covered. It is unlike that wind or water erosion is occurring.

4.a Hydrologic Balance: Diversions

The diversions were snow covered naturally from falling snow. No snow was push into the diversions ditches. Culverts were open. See pictures.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The mine and loadout sediment ponds contain water. No hazardous conditions were notice. The loadout sediment pond was not discharging.

7. Coal Mine Waste, Refuse Piles, Impoundments

The mine was transporting refuse material to the refuse pile during the inspection.

8. Noncoal Waste

The mine site was clear of trash and other non-coal waste materials.

10. Slides and Other Damage

I did not see any slides or other damages during the inspection.

16.a Roads: Construction, Maintenance, Surfacing

Roads were open and drainage controls were function as design.

18. Support Facilities, Utility Installations

No new support facilities since the last inspection.
